



Pinnacle Wealth Brokers (PWB), in partnership with the Pinnacle 20/20 Foundation (P2020F), has been working to "give back" for the last several years. PWB donates 2.5% of it's annual corporate profits to charity and the P2020F. We continue to strive to use donated funds as efficiently as possible to positively impact targeted communities.

About 20% of donated funds have been used to support Canadian initiatives and charities here at home. 80% has been used in Honduras to build schools, improve education facilities, provide medical instruments in hospitals, or to feed children. To minimize unnecessary expenditures, we work with established registered charitable organizations whenever possible, both in Honduras and in Canada. In the last year our founders have volunteered over 600+ hours of their time.

Why Honduras?

Honduras is one of the poorest countries in the western hemisphere, and their government cannot provide the assistance it's people need for a sustainable life. These people need help, and we can make a big impact. We work in the province of Colon, one of Honduras's most remote (and poorest) areas. The average family is only able to make about \$5 to \$10 USD per day (\$180 to 250 USD/month). Many of these families are single mothers with multiple children, it can be difficult to pay for food let alone luxuries like basic education.

Most adults in the Lucinda area are not able to find employment. There is no government social aid, and little to no government funds for education. The parents must provide funds for uniforms/supplies and pay for any improvements like fixing the school's leaking roof or building a restroom for the children.

The children, if they attend school, often do not proceed beyond grade 3 and only about 20% go beyond grade 9. Most students go to school without having breakfast or snacks, and no lunch making it difficult to focus, learn, and retain the education that their parents have sacrificed to provide.

The Lucinda Lunch Program will be launching this month. Uniforms and school supplies needed were bought and distributed to those without, and a plan to feed not only the children in the Lucinda school but also schools in neighboring Margarita and Naranjal will be implemented. Funds from Pinnacle 20/20 will be feeding 250+ kids three times a week until the end of November 2018!

Our goals for the next 3 months:

- Raise \$150 per student for Public Schools for uniforms, school supplies and lunch supplies for the 2019 school year (600 children).
- Fix 2/3 of schools tin roofs before rainy season as they are rusted and leaking.
- Construct a bathroom with plumbing and running water in the Margarita and Naranjal schools as they currently use an outhouse.
